HOMEOWNER DATA RELEASE AND LOAD MANAGEMENT AUTHORIZATION

I have enrolled in the Cape Hatteras Electric Cooperative ("the Utility") ChargePoint Electric Vehicle Charger Residential Rebate program (the "Program") pursuant to which a \$100 rebate is available for the installation of a ChargePoint brand Level 2 electric vehicle home charger in my Hatteras Island home. I understand that, as a condition to my participation in the Program, I am required to authorize ChargePoint, Inc., to release usage information (the "Usage Information") generated by my ChargePoint Home residential charging station and to assist the Utility with certain energy management tasks that I have authorized the Utility to perform in connection with the Program. I understand and agree that the Program is being offered solely by the Utility and not by ChargePoint. I hereby agree that ChargePoint shall have no liability whatsoever from the Utility's failure to deliver any of the benefits offered by the Utility in connection with the Program, and hereby forever release and disclaim, on behalf of myself, my heirs and assigns, ChargePoint from any and all claims I may have against it, its employees, officers and directors arising out of or in connection with the Utility's failure to deliver such benefits.
